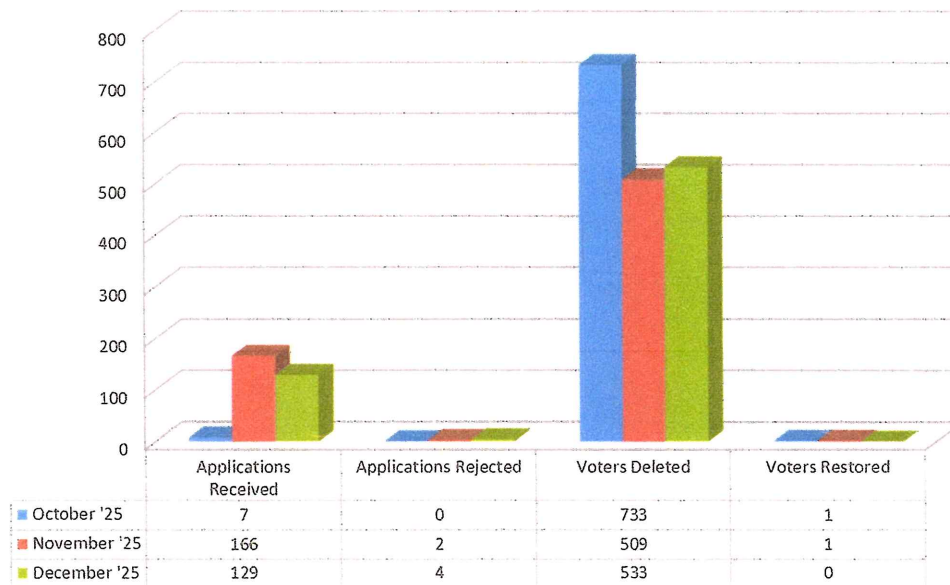
I. OFFICE:
