Sub Recipient's General Information

1. Provide sub recipient's mission statement

CEC Mission Statement- To enhance the quality of life and autonomy of its participants, while enabling them to live in their home and in the community for as long as it is medically and socially feasible.

2. History (including year started)

Cherokee Elder Care is a non-profit entity of the Cherokee Nation that is governed by the Cherokee Nation Comprehensive Care Agency board (CNCCA). The CNCCA board was established in January 2004. The agency was created to facilitate various Cherokee Nation health care business initiatives, including joint ventures and other business-related health activities. Cherokee Elder Care (CEC) opened August 1, 2008 with two enrolled participants. CEC currently has an enrollment of 200 participants served within the approved service area.

3. Regional Profile (regional population; growth projection)

The Cherokee Elder Care 7-county service area has maintained a consistent population trend. Currently, around 18% of the region's residents are 65 years or older, while those aged 55–64 make up 13% of the currently population. The total proportion of elderly adults that reside in Cherokee Elder Care's region averages 31%. This demographic trend has remained stable over recent years, indicating a continued and predictable need for elder-focused services. Cherokee Elder Care serves not only Cherokee County but also neighboring areas, including portions of Adair, Muskogee, and Mayes Counties. The proportion of residents aged 55 and older continues to hold steady, reinforcing the importance of ongoing planning and support for aging populations across the region.

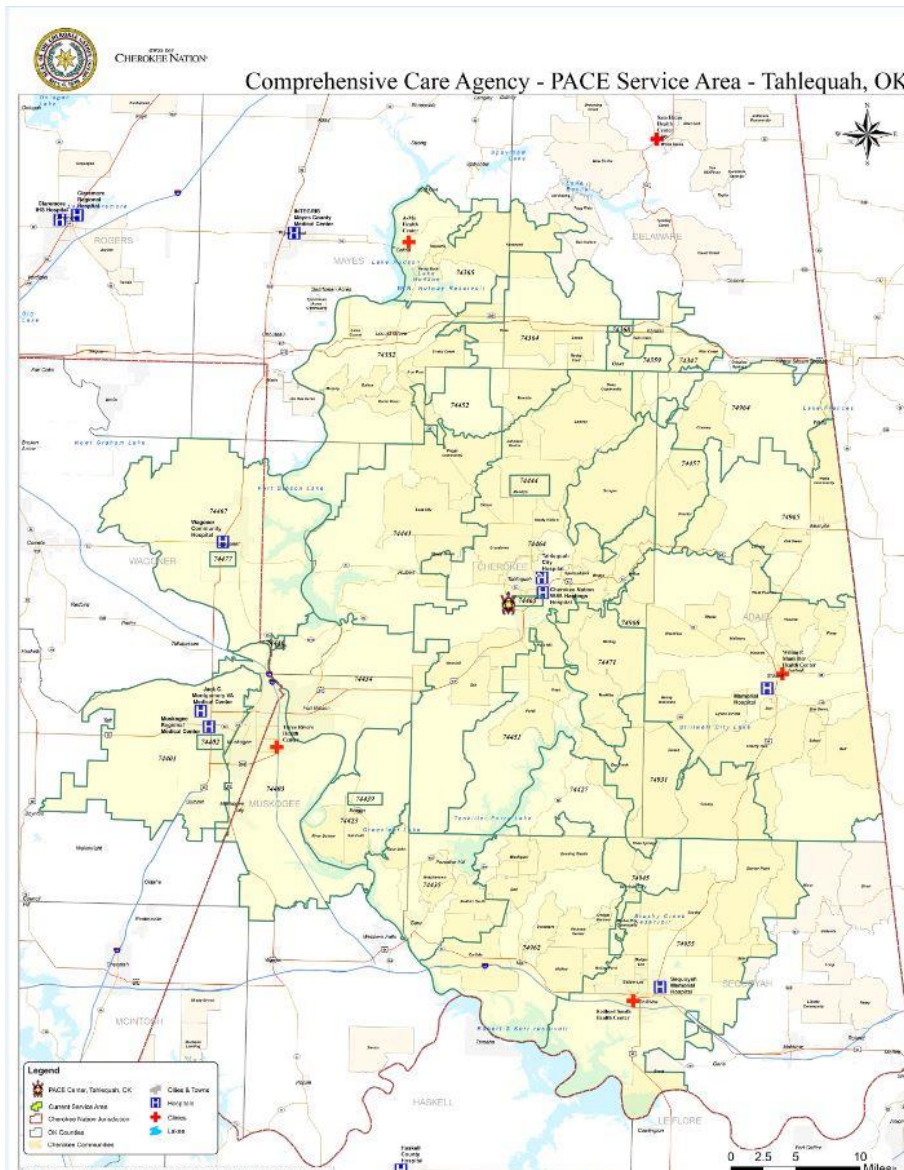

Cherokee Elder Care has 14 regular full time and 3 PRN drivers to cover the below identified service area highlighted in green. The transportation manager schedules the daily routes for each driver and assigns the appropriate van based on program participant needs and handicapped accessibility van features. Currently, the Cherokee Elder Care fleet consists of 20 vans of various service capacities.

Procedures for Filing a Complaint

The complaint procedures apply to the beneficiaries of Cherokee Elder Care programs, activities, and services.

RIGHT TO FILE A COMPLAINT: Any person who believes they have been discriminated against on the basis of race, color, or national origin by Cherokee Elder Care may file a Title VI complaint by completing and submitting the agency's **Title VI Complaint Form**. Title VI complaints must be received in writing within 180 days of the alleged discriminatory complaint.

HOW TO FILE A COMPLAINT: Information on how to file a Title VI complaint is posted on our agency's website, and in public areas of our agency including the CEC Adult Day Health Center lobby, employee break room and the administration building bulletin board.

You may download the Cherokee Elder Care's Title VI Complaint Form at <http://eldercare.cherokee.org/Home>, or request a copy by writing to 1387 W. 4th Street Tahlequah, OK 74464. Information on how to file a Title VI complaint may also be obtained by calling Cherokee Elder Care at (918) 453-5161.

You may file a signed, dated complaint no more than 180 days from the date of the alleged incident. The complaint should include:

- Your name, address and telephone number;
- Specific, detailed information (how, why, and when) about the alleged act of discrimination; and
- Any other relevant information, including the names of any persons, if known, the agency should contact for clarity of the allegations.

COMPLAINT ACCEPTANCE: Cherokee Elder Care will process complaints that are complete. Once a completed Title VI Complaint Form is received, Cherokee Elder Care will review it to determine if Cherokee Elder Care has jurisdiction. The complainant will receive an acknowledgement letter informing them whether or not the complaint will be investigated by Cherokee Elder Care.

INVESTIGATIONS Cherokee Elder Care will generally complete an investigation within 90 days from receipt of a completed complaint form. If more information is needed to resolve the case, Cherokee Elder Care may contact the complainant. Unless a longer period is specified by Cherokee Elder Care, the complainant will have ten (10) days from the date of the letter to send requested information to the Cherokee Elder Care investigator assigned to the case.

If the requested information is not received within that timeframe the case will be closed. Also, a case can be administratively closed if the complainant no longer wishes to pursue the case.

LETTERS OF CLOSURE OR FINDING: After the Title VI investigator reviews the complaint, the Title VI investigator will issue one of two letters to the complainant: a closure letter or letter of finding (LOF).

Attachment D

- A closure letter summarizes the allegations and states that there was not a Title VI violation and that the case will be closed.

- A Letter of Finding (LOF) summarizes the allegations and provides an explanation of the corrective action taken.

If the complainant disagrees with Cherokee Elder Care's determination, the complainant may request reconsideration by submitting the request in writing to the Title VI investigator within seven (7) days after the date of the letter of closure or letter of finding, stating with specificity the basis for the reconsideration. Cherokee Elder Care will notify the complainant of the decision either to accept or reject the request for reconsideration within ten (10) days. In cases where reconsideration is granted, Cherokee Elder Care will issue a determination letter to the complainant upon completion of the reconsideration review.

Cherokee Elder Care's Limited English Proficiency Plan

Introduction

This Limited English Proficiency (LEP) Plan has been prepared to address Cherokee Elder Care's responsibilities as a recipient of federal financial assistance as they relate to the needs of individuals with limited language skills. The plan has been prepared in accordance with Title VI of the Civil Rights Act of 1964; Federal Transit Administration Circular 4702.1B, dated October 1, 2012, which states that the level and quality of transportation service is provided without regard to race, color, or national origin.

Executive Order 13166, "Improving Access to Services for Persons with Limited English Proficiency", indicates that differing treatment based upon a person's inability to speak, read, write or understands English is a type of national origin discrimination. It directs each agency to publish guidance for its respective recipients clarifying their obligation to ensure that such discrimination does not take place. This order applies to all state and local agencies which receive federal funds, including all Cherokee Elder Care's departments receiving federal grant funds.

Cherokee Elder Care has developed this LEP Plan to help identify reasonable steps for providing language assistance to persons with LEP who wish to access services provided. As defined Executive Order 13166, LEP persons are those who do not speak English as their primary language and have limited ability to read, speak, write or understand English. This plan outlines how to identify a person who may need language assistance, the ways in which assistance may be provided, staff training that may be required, and how to notify LEP persons that assistance is available.

To determine if the sub recipient is required to file an LEP Plan, first fill out the LEP Four Factor Analysis form.

LEP Four Factor Analysis

In order to prepare this plan, Cherokee Elder Care used the four-factor LEP analysis which considers the following factors:

- 1. The number or proportion of LEP persons in the service area who may be served or are likely to require Cherokee Elder Care services.**

Cherokee Elder Care staff reviewed updated language demographic data for the **7-county service area**, where a total of **539,498 people** were assessed. It was determined that approximately **93%** of the population primarily speaks **English** at home. Additionally, **2%** speak **Spanish**, **0%** speak **Cherokee**, and **5%** speak **other languages**. The "**other languages**" category includes **Indo-European, Asian or other Pacific Islander**, and **additional languages**. These findings help guide Cherokee Elder Care in planning for language accessibility and ensuring culturally appropriate services across the region.

2. The frequency with which LEP persons come in contact with Cherokee Elder Care services.

Cherokee Elder Care staff reviewed the frequency with which the board/council, office staff and bus drivers have or could have, contact with LEP persons. This includes documenting phone inquiries of office visits. Between November 2024 and July 2025, Cherokee Elder Care received zero (0) requests for translated programs and documents and three (3) requests for sign language interpreters. Additionally, Cherokee Elder Care received two (2) additional requests for sign language interpreters in that same time period. Furthermore, we received requests from two (2) individuals who cannot read.

3. The nature and importance of services provided by Cherokee Elder Care to the LEP population.

Example Language: There is no large geographic concentration of any type of LEP individuals in the service area for Cherokee Elder Care. The overwhelming majority of the population, **93%**, speaks only English. As a result, there are few social, service, professional and leadership organizations within Cherokee Elder Care's service area that focus on outreach to LEP individuals. Cherokee Elder Care's Board/council, office staff and bus/van drivers are most likely to encounter LEP individuals through office visits, phone conversations, and attendance at community meetings.

4. The resources available to Cherokee Elder Care and the overall costs to provide LEP assistance.

Example Language: **Cherokee Elder Care** reviewed its available resources that could be used for providing LEP assistance and which of its documents would be most valuable to be translated if the need should arise. Cherokee Elder Care has documents available in both Spanish and Cherokee. Cherokee Elder Care has contacted local citizens that would be willing to provide voluntary sign language(s) translation if needed, within a reasonable time period. Other language translation if needed would be provided through a telephone interpreter line for which the Cherokee Elder Care would pay a fee. Cherokee Elder Care also has forms available in braille.

Based on the Four Factor Analysis, Cherokee Elder Care chose Option 2 to complete the LEP Plan:

Option 2: Based on the Four Factor Analysis, our research shows that in the Cherokee Elder Care service area, we exceed the minimum requirement of 5% or 1,000 individuals whichever is less. Therefore, a LEP Plan is required. Listed below are the resources used to obtain this information. Examples of resources can be found at Attachment I.

Cherokee Elder Care agrees to the following requirements of an LEP Plan as mentioned below:

Language Assistance

A person who does not speak English as their primary language and who has a limited ability to read, write, speak or understand English may be a Limited English Proficient person and may be entitled to language assistance with respect to Cherokee Elder Care services. Language assistance can include interpretation, which means oral or spoken transfer of a message from one language into another language and/or translation, which means the written transfer of a message from one language into another language.

Cherokee Elder Care staff will identify persons who speak English “not well” or “not at all” by:

- Posting notice of LEP Plan and the availability of interpretation or translation services free of charge in languages LEP persons would understand.
- Informally surveying experiences concerning any contacts with LEP persons during the previous year.
- Offering a translator (LEP) or interpreter (sign language for hearing impaired individuals), as needed, at informational meetings or events. Volunteer interpreters for the Cherokee and Spanish language(s) are available and will be provided within a reasonable time period. Additionally, a staff person may greet participants as they arrive. By informally engaging participants in conversation, it is possible to gauge each attendee’s ability to speak and understand English. Although translation may not be able to be provided at the event, it will help identify the need for future events.

Staff Training

The following training will be provided to all Cherokee Elder Care staff:

- Information on the Title VI Policy and LEP responsibilities.
- Description of languages assistance services offered to the public.

- Documentation of language assistance requests.
- How to handle a potential Title VI / LEP complaint.

All contractors or subcontractors performing work for Cherokee Elder Care will be required to follow the Title VI / LEP guidelines.

Translation of Documents

After weighing the cost and benefits of translating documents for potential LEP groups, and considering the expense of translating the documents, the likelihood of frequent changes in documents and other relevant factors, Cherokee Elder Care will consider the following options:

- Initiate an outreach program for translation services.
- When staff prepares a document or schedules a meeting for which the target audience is expected to include LEP individuals, then documents, meeting notices, flyers, and agendas will be printed in an alternative language based on the known LEP population.

Monitoring and Updating the LEP Plan

Cherokee Elder Care will update the LEP Plan as required. At a minimum, the plan will be reviewed and updated when data from the next U.S. Census is available, or when it is clear that higher concentrations of LEP individuals are present in Cherokee Elder Care service area. Updates will include the following:

- The number of documented LEP person contacts encountered annually.
- How the needs of LEP persons have been addressed.
- Determination of the current LEP population in the service area.
- Determination as to whether the need for translation services has changed.
- Determine whether local language assistance programs have been effective and sufficient to meet the need.
- Determine whether Cherokee Elder Care financial resources are sufficient to fund language assistance resources needed.
- Determine whether Cherokee Elder Care fully complies with the goals of this LEP Plan.
- Determine whether complaints have been received concerning the agency's failure to meet the needs of LEP individuals.
- Maintain a Title VI complaint log, including LEP to determine issues and basis of complaints.
